What Can I Get Help For?

The Acute Care Facility at Larimer County's Longview Campus is available for anyone in a self-defined behavioral health crisis whose needs cannot be safely met in a less restrictive environment. Our team of dedicated professionals provide compassionate care in a non-judgmental, safe environment. Some of the more common conditions we treat include:

- Bipolar Disorder
- Depression
- Grief and Loss
- Hallucinations
- Substance Use / Addiction
- Withdrawal Management (Detox)
- Medication Management and Stabilization (including medications for addiction)
- Schizophrenia
- Stress
- Suicidal / Homicidal Thoughts
- Trauma (PTSD, RAD, DSED, ASD)

Additional Crisis Services

- Mobile Response Services can be dispatched within Larimer County 24/7/365
- 23-hour observation under the care of an integrated behavioral health team when appropriate
- Psychiatric services and medications
 available for walk-in assessment

Unit Features & Daily Schedule

- Room and board, including nutritious meals and snacks
- Access to on-site gym
- Psychiatric evaluation and medication administration
- Individual and group therapy
- Visiting hours
- Connection to resources
 upon discharge

Help for Those Who Are:

- Experiencing harmful behaviors or wanting to harm others
- In a self-defined behavioral health crisis
- On an Emergency Commitment (up to a 5-day hold, 120 hours)
- Need support managing withdrawal
